# THE NINETY SIXTH SYNOD OF THE ANGLICAN DIOCESE OF BRITISH COLUMBIA MINUTES OF SYNOD OCTOBER 24-26

Registration for all delegates to the 96<sup>th</sup> Synod of the Anglican Diocese of British Columbia commenced at 3.30 pm Friday, October 24, 2014, in the Chapel of the New Jerusalem of Christ Church Cathedral.

#### OPENING SERVICE

The Synod opened in Christ Church Cathedral at 6.00pm with a celebration of the Holy Eucharist. The Officers of Synod, the Cathedral Chapter, the Regional Archdeacons and the Diocesan Canons robed and processed. In attendance was The Right Reverend James Mathes, Bishop of San Diego, The Reverend Dr. Richard Topping, Principal of Vancouver School of Theology and Dr. Andrea Mann, Co-coordinator, Global Relations, Partnership. (Anglican Church of Canada). The clergy joined the delegates in the congregation. The Bishop, the Right Reverend Dr. Logan McMenamie, presided and preached. During the service the Collation of Archdeacons Penelope Black and Lon Towstego took place. Bishop McMenamie appointed Lieutenant, the Reverend Jeannine Friesen a Canon of the Cathedral and she was duly seated with the other Cathedral Canons.

# BISHOP'S CHARGE (part 1)

At 9.45AM the Bishop began his charge with a Power Point Presentation of his visits around the diocese. There was a refreshment break until 10.45am.

Upon returning from the refreshment break Archdeacon Alan Naylor, Chair of Nominations, updated the Synod on the nominations still needed for positions:

1 more (at least) lay nomination for General Synod

2 more (at least) lay nominations for Provincial Synod

The regions of Selkirk and Cowichan/Malaspina will need to caucus their delegates and each nominate a lay person to sit on Diocesan Council.

#### VISION AND PRIORITIES

The Reverend Anne Privett and Mr. Rob Crosby-Shearer, co-chairs of the Diocesan Visioning Team spoke to the report "Renewed Hearts, Renewed Minds and Renewed People: A vision for the Anglican Diocese of British Columbia, 2014-2018"

They spoke to the Vision and Priorities asking the table groups to discuss "What would you add to the report and how could it be improved". Each table was to record the discussion and at the appointed time to name some of those additions and improvements for the whole of the gathered Synod. The record of the discussions were given to the Co-chairs of the Visioning Team.

# Bishop's Charge - part II

The Bishop presented the second portion of his charge which was followed by an opportunity to hear from our First Nations brothers and sisters. This portion of the afternoon sitting was introduced by Sister Brenda Jenner, SSJD and the Venerable Low Towstego. The Reverend Canon Dr. Martin Brokenleg led the Synod in an exercise to explore how our understandings of our First Nations brothers and sisters has changed and how that has impacted our lives. We spent some time in table groups sharing our revelations.

We then moved to a panel composed of Mr. Victor Flett, Mr. Bob Nye, the Reverend Lincoln McKoen and Ms Thea Stenholt and each were given time to share with the synod some of their experiences in their communities. Members of the Synod were invited to ask questions of the panel. The topics of the National Missing Women's enquiry was raised during the question period with people speaking on both sides of the question of whether the Federal Government should convene a national enquiry. As a result of this discussion a motion will be forth coming. The synod showed their immense appreciation for these individuals and the presentation with applause.

At 2pm the Bishop announced the opening of the ballot boxes.

At 2pm the Treasurer of the Diocese, Mr. Stephen Martin and the Financial Officer of the Diocese, Mr. Murray Crowther began the Finance Report. (The power point presentation is on file). The issue brought up by the treasurer and Finance Officer was that of the outreach portion of the Diocesan Plan of Assessment being assessed as income. This topic was sent to the table groups for discussion. Many responded during the time of feedback from the table groups and as a result a motion will be brought forward.

The Synod broke for a refreshment break at 3pm.

Dr Mann brought the Synod greetings from the National Office of the Anglican Church of Canada. She talked of her recent travels in her capacity as Co-coordinator of Global Relations and Partnerships. She thanked the Diocese of British Columbia for its support of overseas ministries throughout the world.

Bishop Mathes brought greetings to the Synod from the Diocese of San Diego and gave the members of Synod an insight into the changing face of that diocese. He spoke of the compassionate and respectful conversation and debate we had just had over difficult issue and commended the members of synod for their willingness to be involved in such discussions searching for outcomes that would benefit all of God's children.

At 5pm the third sitting was adjourned and following grace said by the Reverend Canon Jim Lyster The synod delegates enjoyed dinner.

#### Closing thoughts by Guests

The Right Reverend Greg Mohr, ELCIC, brought greetings from the BC Synod of the Lutheran Church. He expressed his gratitude for the relationship between the Anglicans and Lutherans. The times are changing in our church and in our world and God is already at work before us. Bishop Mohr commended the members of synod on the way we listened to each other. He said that the easy part was passing the motions. The easy part is adopting a budget of \$1.5 million dollars. The harder part is answering the question "What is God asking me to do?" What does it mean to live out this vision? He went on to say that the Spirit is calling you and you had better be uncomfortable because you never know where you are going to go or who you are going to meet.

The Bishop presented Bishop Mohr with a print of the House of Prayer by Canon Frank Nelson.

Elder Mel Good and Elder Alex Nelson also spoke to the Synod and thanked the Bishop and the Members of Synod for the invitation to attend and take part. They asked the members of synod to stand with them as they continue conversations with the government about the adoption and fostering of aboriginal children at risk within their own communities. This is a difficult struggle for our First Nations brothers and sisters and they asked for our prayerful support and encouragement.

The Bishop presented both men with a token of gratitude from the Synod.

The Rev'd Eileen Scully thanked the Bishop for his invitation to this sitting of the Synod. She spoke of her relationship with this diocese through individuals, both lay and clergy of the diocese. The Rev'd Scully told the synod of her role at the National Church office and her responsibilities as the director of Faith, Worship and Ministry.

The Bishop presented the Rev'd Scully with a print of the House of Prayer by Canon Frank Nelson.

Bishop McMenamie thanked the members of synod for their presence and was inspired by the bravery and consideration of all the speakers during the course of the Synod. Communication is very important in the life of the diocese and as members of the diocese we need to recognize that communication is the responsibility of each of us. Bishop McMenamie acknowledged that this sitting of Synod would be the last for some of the members of the clergy:

The Reverend Canon Christopher Parsons is leaving the diocese to take up a position in Freiberg, Germany.

The Reverend Osita Oluigbo is leaving the diocese to take up a position in Bethlehem, Pennsylvania.

The Reverend Suzanne Crerar is leaving the parish of St. Andrew, Sidney to retire.

The Reverend Shelagh Huston is leaving the diocese to retire.
