# 4. Finance Report - monthly financial statements, overdrafts and assessments in arrears as at April 2019.

Gail reported that the diocese is current with all remittances to the Federal Government for payroll and GST. The financial statements reflect a small deficit at the end of April 2019.

St. John, Cobble Hill is no longer in an overdraft, effective May 2019. All parishes are up to date with assessments (with either one month or none owing).

## 5. CTF Withdrawals –

(a) St. Mary, Mayne Island has asked to access monies retroactively from its CTF building maintenance fund for costs incurred in the past few years. Expenses of \$6,831.24 were incurred in 2017, and \$3,780.12 In 2018 for a total of \$10,611.36.

(b) St. John the Divine, Courtenay has installed new duct work and is putting insulation around it. This project and its withdrawal of funds from the Comox Glebe Trust were previously approved by Finance Committee and Diocesan Council. Some funds additional funds are required to meet the cost of their project.

## 6. The Anglican Synod of the Diocese of British Columbia annual Financial Statements.

Gail reported that a Review Engagement has been done on the financial statements, rather than an Audit. Grant Thornton has agreed that the statements are correct. Michael Murgatroyd also reviewed the statements and found them to be correct. The operating fund had a small surplus of \$34,014. The Vision Fund carried forward the portion of unspent \$1.5 million earmarked at Synod, and the \$354,210 is now shown under special purpose fund and will be used towards costs to continue the vision. This addition to the Special Purpose fund was previously approved by Finance Committee and ratified by Diocesan Council. An electronic vote will be requested from Diocesan Council for approval of the Review Financial Statements.

### 7. 2020 Assessment to National Church

Gail reported to Finance Committee that many dioceses in Canada were not sending in their full assessment, and had capped their amounts, sending in the same figure each year for multiple years. The meeting had conversation around the importance of contributing our fair share to the National Church, rather than making up shortfalls from others who are comfortable sending less.

Many points were raised in our discussion of this matter: how the calculation of the 26% assessment is done, whether capping yearly contributions is ethical, how important it is to send our 26% as required. One suggestion was made that an article in the Anglican Journal clearly outlining how the calculation of the Assessment should be made might help dioceses get on the same page. Conversation on this matter will be ongoing.
