1. Opening Prayers were offered by Bishop Logan. The Treasurer called the meeting to order.

2. Regrets and Agenda Review

4. Finance report, monthly financial statement, overdrafts and assessments in arrears as of February 2019

Gail spoke to the financial statements which had been distributed. She pointed out that the 2018 comparatives reflect the year-end statements sent to Grant Thornton, who has not yet commenced work on the year-end.

5. 2018 Budget to 2018 Actual Summary

Circulated was a comparison of the 2018 actual revenue and costs, compared to what was budgeted (for information only.). The operating fund is showing a surplus of \$34,014. In 2017, the operating fund showed a deficit of \$18,915.

In 2019, the Operating Fund and Vision Fund (arising from funds from disestablished parish properties) will be combined into one column on the financial statements. The Capital Asset Fund, Consolidated Trust Fund and Special Purpose Fund will continue to be reflected individually.

6. Anglican Foundation Grant Applications

The diocese is able to make two applications for the April 1 Foundation deadline, and an additional two applications for September 1. The maximum number of grants we can receive in a year is three.

St. John Gualbert (Port McNeill) is reapplying for \$6,223 for windows, a handicap door to the hall, and a scooter shed.

St. Mary the Virgin Heritage Church (Metchosin) is applying for \$15,000 for a new wheel-chair ramp and a correction of a drainage problem.

Michael Murgatroyd reported on his attendance at a meeting hosted by SHARE, a not-for-profit advocacy group which offers research and education in the area of ethical investing. They visit companies and groups, representing shareholders. This interested the Diocesan Investment Committee since they will soon be interviewing candidates for a potential change in investment managers. How will the diocese be represented by our manager?

Michael also reported that the task force who will review St. Peter and St. Paul will be meeting in April as soon as John Steele returns.
