We are tracking close to budget, other than the downgrading of funds expected through Transforming Futures for 2019. St. Peter/St. Paul will receive its parish grant in October and reduce overdraft.

Christ Church Cathedral Educational Society (CCCES) is leasing space in the Annex building at St. Dunstan parish from the Anglican Synod of the Diocese of BC. The lease is being assigned to the Parish of St Dunstan by the Diocese. The capital of \$155,000 to accommodate CCCES is being funded by a loan from the Diocese to CCCES. On assignment of the lease, rental is to be paid monthly by CCCES to St. Dunstan parish. Rental is set at \$8,400 per year for the first 5 years of the term of the lease (\$700 per month).
